



# Construction Site Management Level 6



### Who is this qualification for?

This qualification is for experienced construction site managers who oversee larger projects and sites. They will have authority, accountability and clearly be decision-makers. As a minimum they will be involved in:

- ✓ Controlling project progress
- ✓ Allocating work and checking people's performance
- ✓ Controlling project quantities and costs
- $\checkmark$  Implementing and managing health and safety systems
- ✓ Monitoring quality standards
- ✓ Organising, monitoring and controlling supplies of materials
- ✓ Establishing project dimensional control criteria
- ✓ Monitoring environmental factors and sustainibility

There are five pathways to this qualification: Building and Civil Engineering, Highways and Maintenance Repair, Residential Development, Conservation, and Demolition.

**Please Note**: Construction site managers that oversee smaller-scale sites or multiple sites at any one time may find the Level 6 NVQ in Construction Contracting Operations Managemenet (General Contracting Pathway) a more appropriate qualification.



## Is this qualification eligible for the CITB Grant?

Yes, CADUK are a CITB 'ATO' and this Level 6 NVQ is eligible for the CITB Short Period Qualification Grant scheme. This enables CITB registered companies to claim back **£1500** on completion of the qualification.



## Does this qualification provide access to MCI0B?

Yes, this Level 6 NVQ provides the opportunity for learners to apply for Chartered Membership with The CIOB through the Full Professional Review. Generally, applicants will need at least 3 years' experience in construction management in order to be successful.

#### How is this qualification assessed?

This qualification is assessed online with no classroom-based element and no site visits required. We have options to complete this NVQ at your own pace through our ePortfolio system (via written work), or for the more experienced manager we have a **fast-track assessment** option - which is assessed entireley through 'professional discussion' with your assessor and involves no written work.

#### How long does this NVQ take to complete?

We provide support for a period of 12 months, however a realistic timeframe for completion of this qualification is 2-3 months through the 'standard' (written work) assessment method, or 2-4 weeks through the '**fast-track**' (discussion-style) assessment.

#### What are the entry requirements?

No prior qualifications are required in order to apply for this NVQ. Candidates will however have to undertake a short profiling session with their assessor to make sure that they can be successful (i.e. - they have the experience, skills, knowledge and required workplace evidence) before they are approved to enrol onto the qualification. There is no charge for this profiling session.

- ✓ Recognised as comparable to a Bachelor's degree in construction management (OFQUAL).
- ✓ Increased earning potential
