



## Who is this qualification for?

This competence-based NVQ assessment is for highly experienced, senior construction managers. As a minimum, these managers will:

- ✓ Oversee projects from inception to handover
- ✓ Prepare a strategy for the project and select the project team accordingly
- ✓ Evaluate project information to determine project risks and opportunities
- ✓ Encourage a culture of health, safety and welfare on the project
- ✓ Evaluate construction information and present it in different formats
- ✓ Undertake personal development and manage the development of others
- ✓ Provide ethical advice and judgement on technical construction issues
- ✓ Identify quality standards and relay them to the project team
- ✓ Plan and manage a construction organisation's workforce

..this includes roles such as senior project managers, contracts and production managers, commercial managers, operations directors of smaller construction companies, property and facilities managers and specialist construction managers.



# Is this qualification eligible for the CITB Grant?

Yes, CADUK are a CITB 'ATO' and this Level 7 NVQ is eligible for the CITB Short Period Qualification Grant scheme. This enables CITB registered companies to claim back £1500 on completion of the qualification.



# Does this NVQ provide the fast-track route to MCIOB?

Yes, this NVQ provides access to MCIOB through the shortened review process. All of our assessors for this qualification are Members and Fellows of The CIOB themselves and will help you every step of the way with your application at no additional charge.



#### How is this qualification assessed?

This qualification is assessed entireley online, through provision of workplace evidence and 'professional discussion' with your construction specialist (MCIOB/FCIOB) NVQ assessor. During these discussions you will be describing to your assessor how you carry out your role as a construction manager and explaining the link between the documentation (evidence) and the process. There is no written work, no classroom-based element and no site visits required.



#### What are the entry requirements?

No prior qualifications are required in order to apply for this Level 7 NVQ. Candidates will however have to undertake a short profiling session with their assessor to make sure that they can be successful (i.e. - they have the experience, skills, knowledge and required workplace evidence) before they are approved to enrol onto the qualification. There is no charge for this profiling session.



#### How long does this NVQ take to complete?

We provide support for a period of 12 months, however a realistic completion time for this qualification is 1-3 months.
