



Who is this qualification for?

This qualification is for those responsible for developing and applying health and safety procedures day-to-day in their organisation. They may be a staff member, supervisor or manager and will will report directly to, or be part of the senior management team. They will:

- ✓ Identify, assess and control health and safety risks.
- ✓ Develop and implement the health and safety policy.
- ✓ Develop and implement communication systems for health and safety information.
- ✓ Develop and implement proactive and reactive monitoring systems for health and safety.
- ✓ Develop and implement health and safety emergency response systems and procedures.
- ✓ Develop and implement health and safety review systems.

This qualification is appropriate to learners from a variety of sectors including Energy, Oil & Gas, Retail, Corporate Business and Construction.



Does this qualification provide access to GradIOSH?

Yes, this NVQ enables candidates to apply for Graduate Membership of The Institution of Occupational Safety and Health (GradIOSH) on completion. This paves the way to Chartered Membership of IOSH (CMIOSH).



What is the difference between NEBOSH and the NVQ Level 6?

NEBOSH is a qualification aimed at those who wish to gain an in-depth understanding of health and safety practice. The NVQ Level 6 is for those that already have an in-depth knowledge, are already working in a senior health and safety role and want recognition of their competence.



How is this qualification assessed?

This qualification is assessed online with no classroom-based element and no site visits required. We have options to complete this NVQ at your own pace through our ePortfolio system (via written work), or for the more experienced manager we have a **fast-track assessment** option - which is assessed entireley through 'professional discussion' with your assessor and involves no written work.



How long does this NVQ take to complete?

We provide support for a period of 12 months, however a realistic timeframe for completion of this qualification is 2-3 months through the 'standard' (written work) assessment method, or around 1 month through the 'fast-track' (discussion-style) assessment.



What are the entry requirements?

No prior qualifications are required in order to apply for this NVQ. Candidates will however have to undertake a short profiling session with their assessor to make sure that they can be successful (i.e. - they have the experience, skills, knowledge and required workplace evidence) before they are approved to enrol onto the qualification. There is no charge for this profiling session.
