



# Occupational Work Supervision Level 3



## Who is this qualification for?

This qualification is designed for Occupational Work Supervisors (gangsters) i.e. those who contribute to the supervision of general building work, such as bricklayers, carpenters, plumbers, electrical installations, formworkers, steelfixers, construction operatives, window installers, timber frame operators, logistics teams, labouring teams etc.

CADUK offer a unique fast-track route for this qualification which can enable very experienced supervisors to complete this NVQ within a one-day assessment. This assessment is carried out through a combination of discussion with your NVQ assessor and the submission of workplace evidence (videos, photos and documents). Documentation will include a RAMS, toolbox talk, induction, progress report, plant allocation sheet, etc

Please Note: This is not a training course, it is an assessment of competence through the recognition of the skills, knowledge and experience that you already have. This fast-track route is therefore only suitable for very experienced, competent and confident supervisors/gangsters and is not suitable for those new to the role or those that are still developing their abilities as a supervisor.



### Is this qualification eligible for the CITB Grant?

Yes, CADUK are a CITB 'ATO' and this Level 3 NVQ is eligible for the CITB Short Period Qualification Grant scheme. This enables CITB registered companies to claim back **£1200** on completion of the qualification.



### How can I tell if I would be eligible for this fast-track assessment?

Typically applicants will need at least 3 years' experience supervising a construction trade. Before enrolment you will have a profiling session over the phone with your NVQ assessor. This (free) session is to determine whether or not you would be suitable for the fast track route.



### How is this qualification assessed?

The whole assessment will be captured by photos and video recordings. You will be required to present various workplace documents to your assessor, including a RAMS, toolbox talk, induction, progress report, plant allocation sheet, etc. The knowledge-based element (i.e. the 8 units of the qualification) will be assessed verbally through recorded discussion with your assessor.



### How long does this NVQ take to complete?

It is expected that candidates on this fast-track route will complete the assessment within one day. This will however require a degree of preparation beforehand from the candidate (such as evidence collection).



### What are the entry requirements?

No prior qualifications are required in order to apply for this NVQ although it is preferable to hold a Level 2 NVQ or similar qualification in the trade that you are supervising. Candidates will also have to complete a telephone profiling session with their assessor before being approved to enrol onto the qualification. There is no charge for this profiling session.
