



## Who is this qualification for?

This qualification is designed for site inspectors, architectural inspectors and quality inspectors i.e. those who carry out the role of Clerk of Works.

The Clerk of Works ensures value for money for the client rather than the contractor through rigorous and detailed inspection of materials and workmanship throughout the building process.

Achievement of this qualification enables learners to apply for Licentiate (LICWCI) or Membership (MICWCI) of The Institute of Clerk of Works and Construction Inspectorate. The grade of membership you can achieve depends on your experience in the duties/responsibilities associated with a construction inspection (or similar) role.

Please Note: This Level 6 qualification is accessible only to those that are **already** working in a senior quality inspection/Clerk of Works role, they will have responsibility for monitoring project quality, and managing project progress and handover in construction.



# Is this qualification eligible for the CITB Grant?

Yes, CADUK are a CITB 'ATO' and this Level 6 NVQ is eligible for the CITB Short Period Qualification Grant scheme. This enables CITB registered companies to claim back £1500 on completion of the qualification.



# Does this qualification provide access to MCIOB?

Yes, this Level 6 NVQ provides the opportunity for learners to apply for Chartered Membership with The CIOB through the Full Professional Review. Generally, applicants will need at least 3 years' experience in construction management in order to be successful.



#### How is this qualification assessed?

This qualification is assessed online with no classroom-based element and no site visits.

Candidates will be provided with access to our online ePortfolio portal where they will be required to describe how they carry out their role, and present workplace documents/evidence (such as quality reports, minutes of meetings, emails, photographs, snagging lists, etc) that validates their description.



#### How long does this NVQ take to complete?

We provide support for a period of 12 months, however a realistic timeframe for completion of this qualification is 1-3 months depending on the motivation of the candidate.



#### What are the entry requirements?

No prior qualifications are required in order to apply for this NVQ. Candidates will however have to undertake a short profiling session with their assessor to make sure that they can be successful (i.e. - they have the experience, skills, knowledge and required workplace evidence) before they are approved to enrol onto the qualification. There is no charge for this profiling session.
